#### MONTANA COLUMBIA SHEEP SALE RULES AND REGULATIONS

- All sheep will be given a Health Inspection by a qualified veterinarian. Any sheep not passing the inspection will be removed from the sale. The veterinarian may sift immature or unsound entries. The veterinarian's decision on health matters is final. NOTE: All sheep must have been dipped, sprayed or treated with an approved preparation at least 10 but no more than 70 days prior to the sale.
- 2. All of the unregistered ewe lambs will be combined and offered for sale as one group, buyers' choice of 4 head increments or the entire group.
- 3. GUARANTEES: All rams selling for \$300.00 or more are guaranteed to be breeders. If a ram proves to be a non-breeder, the seller will refund the purchase or make a comparable replacement.
- 4. SALE ORDER: Registered rams and registered ewes that are judged will be sold in the order in which they are placed by the Judge(s). The sale order for the other sheep in the sale will be determined by drawing numbers.
- 5. Terms of the sale are cash. All animals must be paid for before leaving the grounds. Checks for any sheep bought at "private treaty," either before or after the regular sale, must be made to the sale committee and become a portion of the sale receipts.
- 6. All bidding will be based on a price per head. Sellers have the right of bidding once on each lot offered, but such bids, must be given to the auctioneer as the lot enters the ring. By bidding is not permitted.
- 7. If, for any reason, a consignor withdraws on or more lot of his or her sheep during the sale, those sheep so withdrawn must go back to their pen and cannot be run through the ring at a later time.
- 8. Misunderstandings or disputes as to bids will be settled by the Auctioneer or bid caller.
- 9. All sheep consigned are held at the consignor's risk until sold. Ownership changes when the sheep are sold in the ring. Sheep are held at purchaser's risk after the sale.
- 10. The Columbia Sheep Breeders Association of Montana disclaims liability for any injury or damage to person or property resulting from any cause while on the sale grounds.
- 11. No dogs are allowed in or around the sale barns.
- 12. Commercial ewes must be whiteface and have a purebred Columbia as one parent. They may be either yearlings or ewe lambs.

This lamb was weaned 7/3 with a ADG of 0.7 off grass with no creep. She recently microned a 22.9. Sire 21773 (shown above) gained 0.77 lbs./day and microned a 24.24 at the 2021-22 NDSU Ram Test. His NSIP numbers are similar to or higher than his sire's. Grandsire 19098 is Montana's First Certified Columbia Ram and was the High Gaining Ram at the 2019-20 NDSU Ram Test. Dam 1209 is 10 years old and has several daughters in the flock.

This lamb was weaned 7/3 off grass with no creep; she weighed 95 lbs., had a WDA of 1.23, an ADG of 1.05, and a WR of 135. She recently microned a 24.5 and is super-thick when viewed from the rear. Sire 21707 was the High Gaining Ram with an ADG of 0.99 and 365-day staple length of 4.66 at the 2021-22 NDSU Ram Test. Dam Y16150 is 6 years old and is in excellent condition. This is only her second single.

This lamb was weaned 7/3 off grass with no creep; she had a WDA of 1.0, an ADG of 0.87, and a weaning ratio of 115. She recently microned a 19.7. Naturally, coarsen a bit with age but should still shear a Line 1 or 2 fleece. Sire B-180 (shown above) was the High Gaining Ram at the 2020-21 Wyoming Ram Test

where he had a 365-day grease fleece weight of 24.9 lbs., 365-day staple length of 5.15 inches and microned a 21.24. Dam 16011 is 7 years old and has had only one other single. Grandsire 1185 was the 2<sup>nd</sup> High Gaining Ram at the 2014-15 MSU Ram Test, is the sire to the 2018 CSBA National Champion Fleece, and is 9 years old. Granddam 734 is 9 years old, only ever had two singles, and I have 3 generations of her daughters in my flock.

This ram had a 365-day staple length of 4.98 inches and was the 2<sup>nd</sup> High Gaining Ram at the 2022-23 NDSU Ram Test. His full brother, 21720 (shown above), had a 365-day grease fleece weight of 18.9 lbs., microned a 25.15 (missing a 60s spin count by 0.2 microns), gained 0.92 lbs./day and was the 2<sup>nd</sup> High Gaining Ram at the 2021-22 NDSU Ram Test. We are using his full brother and his lambs looks really nice. He also has higher weaning NSIP numbers than his sire. Sire 19098 is Montana's First Certified Columbia Ram and was the High Gaining Ram at the 2019-20 NDSU Ram Test. Dam 16034 has a lifetime 230% lamb crop. Grandsire 1185 was the 2<sup>nd</sup> High Gaining Ram at the 2014-15 MSU Ram Test, is the sire to the 2018 CSBA National Champion Fleece, and is 9 years old. Granddam 06-37 never had a single.

## Crossroad Columbias Box 252 Simms 590-5172 or 590-0342

Crossroad Columbias started in 2013 when Conner Klick received his starter flock. Since then, Heidi and Conner had the High Gaining Ram at the 2016-17 MSU Ram Test with a 5 in. ribeye and were three-time back-to-back CSBA National Champion Fleece winners with one fleece being from a lamb.

Shown right is "Shiner Bock," sire to Lot 8-9, who sheared the 2019 and 2021 CSBA National Champion Fleeces. He sired the ram who sheared the 2020 National Champion Fleece. He is also the sire to their certified ram from the 2022-23 NDSU Ram Test.

The Gibbs family have been running sheep since the late 1800's. The registered flock began 28 years ago when Jay Gibbs received a Columbia ewe. From the beginning, the Gibbs family have desired a flock with mothering ability, adequate milk and lambing percentages, quiet dispositions, survivability on range conditions, moderate frames with depth and width, correct structure with good bone and feet, lambs that grow and gain well, and dense fleeces.



The flock had an average lamb crop of 170%, average weaning ratio of 100%, and an average gain test ratio of 100%. These rams were shorn 2-20-2023.

Doug's family has been in the Columbia sheep business since the 1940's. His sheep are *"doing what they were bred for – to work for other people."* Sheep purchased from Doug have sheared the National Champion (2003, 2015) and Reserve Champion (2020) Fleece at the CSBA National Wool Show. Sons of Hitch-bred ewes have shorn fleeces that placed either first (2018) and fourth (2021) at nationals. Of his first consignment to the 2020-21 NDSU Ram Test, one ram sheared the shorn the finest, most uniform Columbia fleece.


